SUBJECT:

That the City Council approves a Change Order to the Reconstruction of Runway 4-22 EPIA, Contract No. 2017-1059 with Jordan Foster Construction LLC (“Contractor”) in the amount of FOUR HUNDRED THREE THOUSAND ONE HUNDRED NINE AND 24/100 DOLLARS (\$403,109.24) to compensate the Contractor pursuant to the Agreement for achieving a higher level of quality of asphalt.

BACKGROUND / DISCUSSION:

Change Order #07 has been created for pay factor adjustments for the P-401 Hot Mix Asphalt (HMA) Pavements Bid Items. The contractor placed Hot Mix Asphalt material whose quality surpassed the acceptable quality level of the FAA, as supported by the material test results. The benefits of using superior materials include a longer operational life, reduced maintenance, and increased safety.
