#### SUBJECT:

Via Ordinance, amend Title 12, Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets), Subsection 240 (Both sides of Westcity Court from Waymore Drive to Eubank Court) of the city code to remove the parking restriction on the east side of Westcity Court from Waymore Drive to Eubank Court. The penalty being provided in Chapter 12.84 of the El Paso City Code.

#### **BACKGROUND / DISCUSSION:**

The Streets and Maintenance Department received a request from an apartment manager to remove the "No Parking Anytime" restriction on Westeity Court from Waymore Drive to Eubank Court. The existing parking restriction has resulted in numerous complaints from tenants as visitors are cited. After investigating this concern, the Streets and Maintenance Department recommends the removal of the existing parking restriction on the east side of Westeity Court from Waymore Drive to Eubank Court.

April 4, 1989

Motion made to prohibit parking at all times on both sides of Westcity Court from Waymore Drive to Eubank Court, be passed.

### ORDINANCE NO.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III—PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS), SUBSECTION 240 (BOTH SIDES OF WESTCITY COURT FROM WAYMORE DRIVE TO EUBANK COURT) OF THE CITY CODE TO REMOVE THE PARKING RESTRICTION ON THE EAST SIDE OF WESTCITY COURT FROM WAYMORE DRIVE TO EUBANK COURT. THE PENALTY BEING PROVIDED IN CHAPTER 12.84 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**SECTION 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III—Parking Prohibited at All Times on Certain Streets), Subsection 240 (Both Sides of Westcity Court from Waymore Drive to Eubank Court), be amended to read as follows:

240. West side of Westcity Court form Waymore Drive to Eubank Court;

**SECTION 2.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
