## Purpose of Item

A request was submitted by an apartment complex manager to remove the “No Parking Anytime” restriction on the east side of Westcity Court from Waymore Drive to Eubank Court.

## Requested Council Action

Via Ordinance, amend Title 12 (Vehicles and traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets), Subsection 240 (Both sides of Westcity Court from Waymore Drive to Eubank Court) of the city code to remove the parking restriction on the east side of Westcity Court from Waymore Drive to Eubank Court. The penalty being provided in Chapter 12.84 of the El Paso City Code.

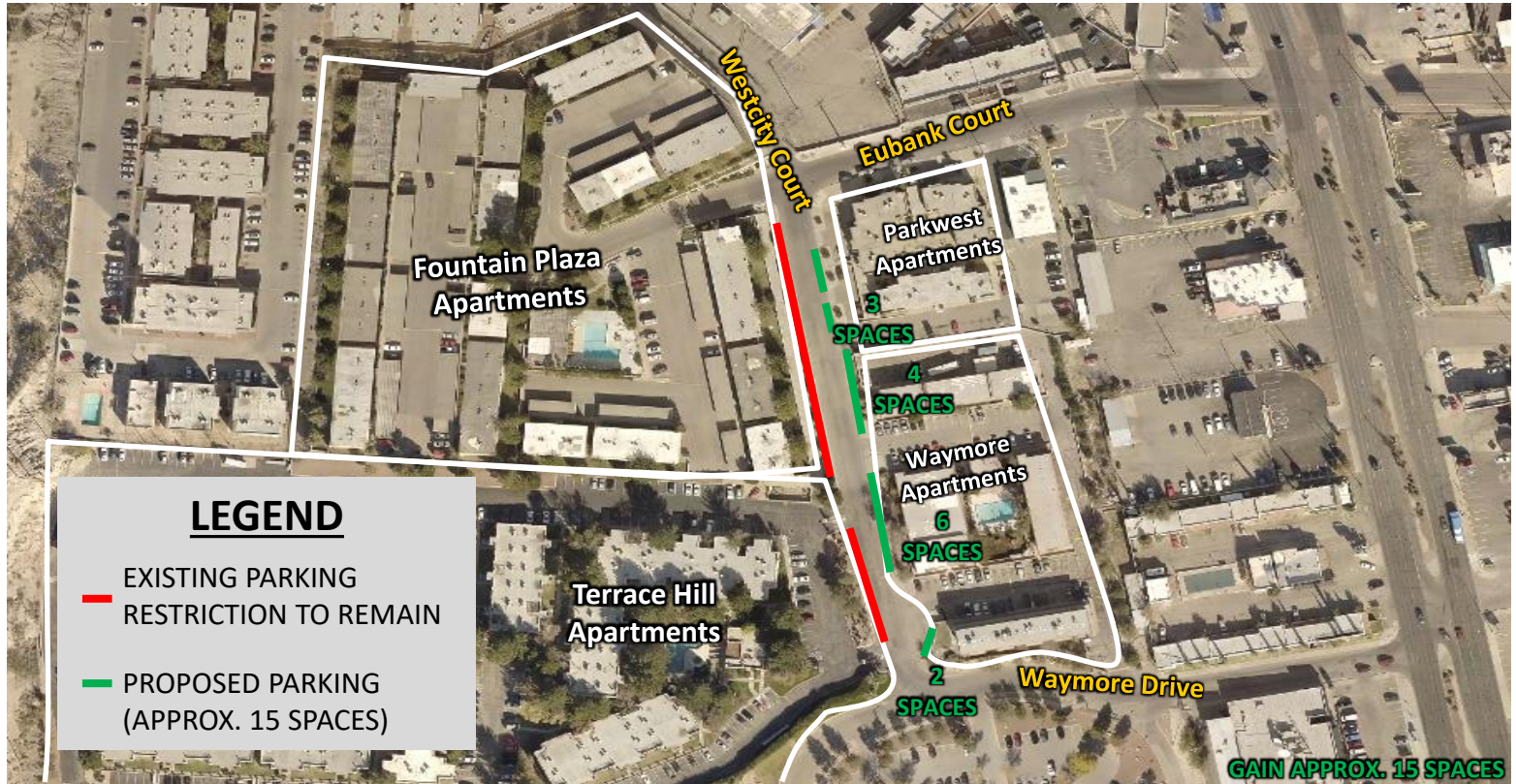
