#### SUBJECT:

Via Ordinance, amend Title 12, Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing – Tow-away zone), Subsection A, Subsubsection 15 of the El Paso City Code, to delete the parking and standing prohibition on both sides of Coles Street form Second avenue to Paisano Drive. The penalty being provided in Chapter 12.84 of the El Paso City Code.

### **BACKGROUND / DISCUSSION:**

The Streets and Maintenance Department received a request from a business owner to remove the "No Stopping or Standing Tow-Away" restriction on Coles Street in front of his business. The construction of the Border West Expressway required the removal of the traffic signal at Paisano Drive and Coles Street as well as converting East First Avenue to a one-way street. These modifications to the area will allow for on-street parking on Coles Street.

### **PRIOR COUNCIL ACTION:**

June 17, 1971

Motion made that the Ordinance amending Section 20-193 (No Parking or Standing on Parts of Certain Streets – Tow-Away Zones), to add both sides of Coles Street form Second Avenue to Paisano Drive, be passed. PASSED AND APPROVED.

Border West Expressway Project:

Motion made that the Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.010 (Schedule I – One-Way Streets), to add a new location at East First Avenue, eastbound from Coles Street to its terminus to be adopted. **MOTION ADOPTED**.

# ORDINANCE NO.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING-TOW AWAY ZONE), SUBSECTION A, SUBSUBSECTION 15 OF THE EL PASO CITY CODE, TO DELETE THE PARKING OR STANDING PROHIBITION ON BOTH SIDES OF COLES STREET FROM SECOND AVENUE TO PAISANO DRIVE.
