### **SUBJECT:**

An ordinance amending title 12 (Vehicles and Traffic), Chapter 12.44 (Stopping, Standing and Parking Generally). Section 12.44.170 (Parking on City-Owned Property), of the el Paso City Code, to add a parking fee exemption for surviving spouses of disabled veterans with identified registered license plates at the El Paso International Airport; the penalty being as provided in Chapter 12.84 of the El Paso City Code.

This amendment to Title 12, will add a parking fee exemption to surviving spouses of disabled veterans with identified registered license plates at the El Paso International Airport. This section does not permit a vehicle to be parked at a time when or a place where parking is prohibited.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.44 (Stopping, Standing and Parking Generally), Section 12.44.170 (Parking on City-owned Property), of the El Paso City Code, is amended to add the following subsection as follows:

## 12.44.170 (Parking on city-owned property)

- F. A vehicle, which displays license plates issued under the applicable Texas Transportation Code section noted below, is exempt from the payment of a parking fee at the El Paso International Airport, provided that the vehicle is being operated at the time of accrual of such parking fee by or for the transportation of the person that registered the vehicle under such Texas Transportation Code provisions:
  - 1. Section 504.317—Surviving Spouse of Disabled Veterans

This section does not permit a vehicle to be parked at a time when or a place where parking is prohibited.

**Section 2.** Except as herein amended, Title 12, Chapter 12.44, of the El Paso City Code shall remain in full force and effect.
