AN ORDINANCE AMENDING ORDINANCE 018564 (ORDINANCE LEVYING 2017 TAXES) TO CORRECT A SCRIVENER'S ERROR.

WHEREAS, on August 23, 2016, the City adopted, in conjunction with the adoption of the City's annual budget, Ordinance No. 018564 levying 2017 ad valorem taxes at the rate of 0.759656 of one percent; and

WHEREAS, the ordinance so adopted inadvertently contained a scrivener's error in the portion of Ordinance No. 018564 that breaks down the tax rate by General and Special Purposes; specifically, under Section 1.A. "For General Purposes", the amount identified is 0.485640 of one percent instead of 0.485641 of one percent; and

WHEREAS, this ordinance is intended to amend and restate Ordinance No. 018564 to correct this scrivener's error; and

WHEREAS, the correction of this scrivener's error will not alter the purpose, intent and effective date of Ordinance No. 018564, nor will it change the ad valorem tax rate of 0.759656 of one percent adopted by the governing body on August 23, 2016.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That SECTION 1.A. to Ordinance No. 018564 be amended to read as follows:
 - A. For General Purposes:
For the General Fund and for the purpose of defraying current municipal expenses of the City of El Paso not otherwise provided for, **0.485641** of one percent.
2. Except as herein amended, Ordinance No. 018564 shall remain in full force and effect.

AN ORDINANCE LEVYING 2017 TAXES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

SECTION 1: That ad valorem taxes for the tax year ending December 31, 2016 to fund the City's budgetary requirements for the fiscal year ending August 31, 2017, be and are hereby levied on all property, real personal, and mixed, subject to taxation by the City, at the rate of **0.759656** of one percent of the assessed value of said property as hereinafter set forth:

A. For General Purposes:

For the General Fund and for the purpose of defraying current municipal expenses of the City of El Paso not otherwise provided for, **0.485640** of one percent.

B. For Special Purposes:

To pay the interest on and provide a Sinking Fund to redeem bonds a total Levy for Special Purposes **0.274015** of one percent.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.


THE TAX RATE WILL EFFECTIVELY BE RAISED BY 0.42 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$2.04.

SECTION 2: Occupational Tax:

There is hereby levied on every person, firm, association or corporation pursuing within the limits of the City of El Paso any occupation taxes by the State of Texas as authorized by City Council an annual tax equal to one-half of the occupation tax levied by the State of Texas thereon.
