Amend Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or Standing – Tow Away Zone), paragraph A)No Parking or Standing, Tow-away Zone), of the El Paso City Code, 106. Pendale Road, the penalty being as provided in section 12.88.180(F) of the El Paso City Code.

BACKGROUND / DISCUSSION:

A petition was submitted by a business owner on the 900 block of Pendale Road to remove the "No Parking Tow-Away" restriction on the west side of Pendale Road from Yermoland Drive to Castner Drive. All businesses on the block signed a petition in agreement with this parking restriction removal.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING – TOW AWAY ZONE), PARAGRAPH A (NO PARKING OR STANDING, TOW-AWAY ZONE), OF THE EL PASO CITY CODE, TO AMEND 106. PENDALE ROAD, THE PENALTY BEING AS PROVIDED IN SECTION 12.88.180(F) OF THE EL PASO CITY CODE.

WHEREAS, Section 12.88.180 of the El Paso City Code prohibits the parking or standing of any vehicle at designated streets when prohibited by a sign; and

WHEREAS, The amendment to Paragraph A of Section 12.88.180 of the El Paso City Code will provide residents and patrons of local businesses with more parking options.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing – Tow-away zone), Paragraph A (No parking or standing, tow-away zone), is hereby amended to read:

106. Pendale Road

- a. West side between Gateway East Boulevard to Yermoland Drive and from Castner Drive to Kastrin Street; and
- b. East side between Gateway East Boulevard to Castner Drive and from a point 900 feet south of Castner Drive to Kastrin Street;

Section 2. Except as herein amended, Title 12, Chapter 12.88, of the El Paso City Code shall remain in full force and effect.


