SUBJECT:

Amend Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets), to prohibit parking along a portion of Manor Place, the penalty being as provided in section 12.88.180(F) of the El Paso City Code.

BACKGROUND / DISCUSSION:

The Capital Improvement Department (CID) has requested to restrict parking for a 135-ft segment of Manor Place, at the intersection with Alameda Avenue, in order to accommodate the new alignment of the reconstructed street. The new alignment allows for two lanes exiting onto Alameda Avenue – one for right-turning traffic and one for left-turning traffic – which requires use of the entire width of the street, preventing space for on-street parking at this location.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III, PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS), OF THE EL PASO CITY CODE, TO PROHIBIT PARKING ALONG A PORTION OF MANOR PLACE, THE PENALTY BEING AS PROVIDED IN SECTION 12.88.180(F) OF THE EL PASO CITY CODE.

WHEREAS, Section 12.88.030 of the El Paso City Code prohibits the parking or standing of any vehicle at designated streets when prohibited by a sign; and

WHEREAS, A portion of Manor Place has been converted to a travel lane making the parking of vehicles a hazard to the public's safety.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III-Parking prohibited at all times on certain streets), is hereby amended to read:

384. Manor Place, from Alameda Avenue to a point one hundred and thirty-five feet south thereof, west side only.

Section 2. Except as herein amended, Title 12, Chapter 12.88, of the El Paso City Code shall remain in full force and effect.




