Amend Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing - Tow-away zone), El Paso City Code, to delete Subsection K (Parking restrictions on Hopewell Drive, Mettler Drive, and Sunburst Drive), the penalty being as provided in section 12.85.

BACKGROUND / DISCUSSION:

A petition was submitted by the Cielo Vista Neighborhood Association to remove the "No Parking Tow-Away" restriction on Hopewell Drive, Mettler Drive, & Sunburst Drive, from Hawkins Boulevard to Cessna Drive. As per the residents, the overflow of patrons attending the surrounding businesses is no longer an issue and would like to have this parking restriction removed.



ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING -TOW-AWAY ZONE), OF THE EL PASO CITY CODE TO DELETE SUBSECTION K (PARKING RESTRICTIONS ON HOPEWELL DRIVE, METTLER DRIVE & SUNBURST DRIVE), THE PENALTY BEING AS PROVIDED IN CHAPTER 12.85 OF THE EL PASO CITY CODE.

WHEREAS, Section 12.88.180(K) of the El Paso City Code provides that when signs are erected no person, except a person who holds a valid parking permit, shall stop, park, or stand any vehicle on certain portions of Mettler Drive, Hopewell Drive, and Sunburst Drive; and

WHEREAS, The residents of the area surrounding Mettler Drive, Hopewell Drive, and Sunburst Drive have requested the removal of the parking restrictions; and

WHEREAS, The City determines that such parking restrictions are no longer necessary.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or standing-Tow-away zone) is hereby amended as follows:

Delete Subsection K, in its entirety.

Section 2. Except as herein amended, Title 12, Chapter 12.88 of the El Paso City Code shall remain in full force and effect.
