The Property Tax Code states that the Tax Collector may issue a refund "within 3 years of the date of the payment" but that "the governing body of the taxing unit may extend the deadline for a single period not to exceed 2 years on a showing of good cause by the taxpayer.

WHEREAS, pursuant to Section 31.11 (c-1) the governing body of the taxing unit may extend the deadline for a single period not to exceed two years on a showing of good cause by the taxpayer; and

WHEREAS, taxpayer, SCG Capital Corporation ("Taxpayer") has applied for a refund with the tax assessor for their 2011 property taxes that were overpaid on January 26, 2012 in the amount of \$8,073.55 for all taxing entities; and

WHEREAS, City Council may extend the deadline for the Taxpayer's application for the overpayment of the 2011 taxes for a period not to exceed two years on a showing of good cause by the taxpayer; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

The Internal Audit office would like to highlight that the Tax Office took 46 days to send the Tax Refund Application to the Internal Audit Office for review once the proof of payment was received. The Tax Refund Application was received by the Tax Office on June 22, 2015. The proof of payment was received by the Tax Office on August 13, 2015. The Tax Refund Application was sent to the Internal Audit Office for review on September 28, 2015.

As required by the City of El Paso's Strategic Goal 6.11 which states: "Provide efficient and effective services to taxpayers". We are extremely concerned with the number of days it is taking to get the application to the Internal Audit Office for review. Forty-six (46) days is an excessive number of days to forward a Tax Refund Application to the Internal Audit Office. It is a burden to the Taxpayer in obtaining their refunds.
