AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III – PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) TO DELETE PARKING RESTRICTIONS ON STANTON STREET BETWEEN BLACKER AVENUE AND CLIFF DRIVE, WEST; STANTON STREET BETWEEN NEVADA AVENUE AND BLACKER AVENUE, EAST SIDE AND STANTON STREET BETWEEN RIO GRANDE AVENUE AND ARIZONA AVENUE, WEST SIDE ONLY. THE PENALTY BEING PROVIDED IN CHAPTER 12.84 OF THE EL PASO CITY CODE.

The purpose of this amendment is to, in support of the El Paso Streetcar, regulate parking along the streetcar route; support new infrastructure and operations; allow towing of illegally parked vehicles; identify designated parking areas along the route; and delete and consolidate existing ordinances along the route.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III—PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) TO DELETE PARKING RESTRICTIONS ON STANTON STREET BETWEEN BLACKER AVENUE AND CLIFF DRIVE, WEST; STANTON STREET BETWEEN NEVADA AVENUE AND BLACKER AVENUE, EAST SIDE AND STANTON STREET BETWEEN RIO GRANDE AVENUE AND ARIZONA AVENUE, WEST SIDE ONLY. NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

<u>SECTION 1.</u> That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III—Parking prohibited at all times on certain streets), Subsection 24. which currently reads "Stanton Street between Blacker Avenue and Cliff Drive, west side;" be amended to now read as follows:

24. Deleted

<u>SECTION 2.</u> That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III—Parking prohibited at all times on certain streets), Subsection 27. which currently reads "Stanton Street between Nevada Avenue and Blacker Avenue, east side;" be amended to now read as follows:

27. Deleted

SECTION 3. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III—Parking prohibited at all times on certain streets), Subsection 129. which currently reads "Stanton Street between Rio Grande Avenue and Arizona Avenue, west side only;" be amended to now read as follows:

129. Deleted

SECTION 4. Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
