Purpose of Amendments

To regulate parking along the El Paso Streetcar route

- To support streetcar infrastructure and operations
- To keep streetcar tracks clear of parked vehicles
- To allow towing of illegally parked vehicles
- To identify designated parking areas along the route
- Deleting and consolidating existing ordinances

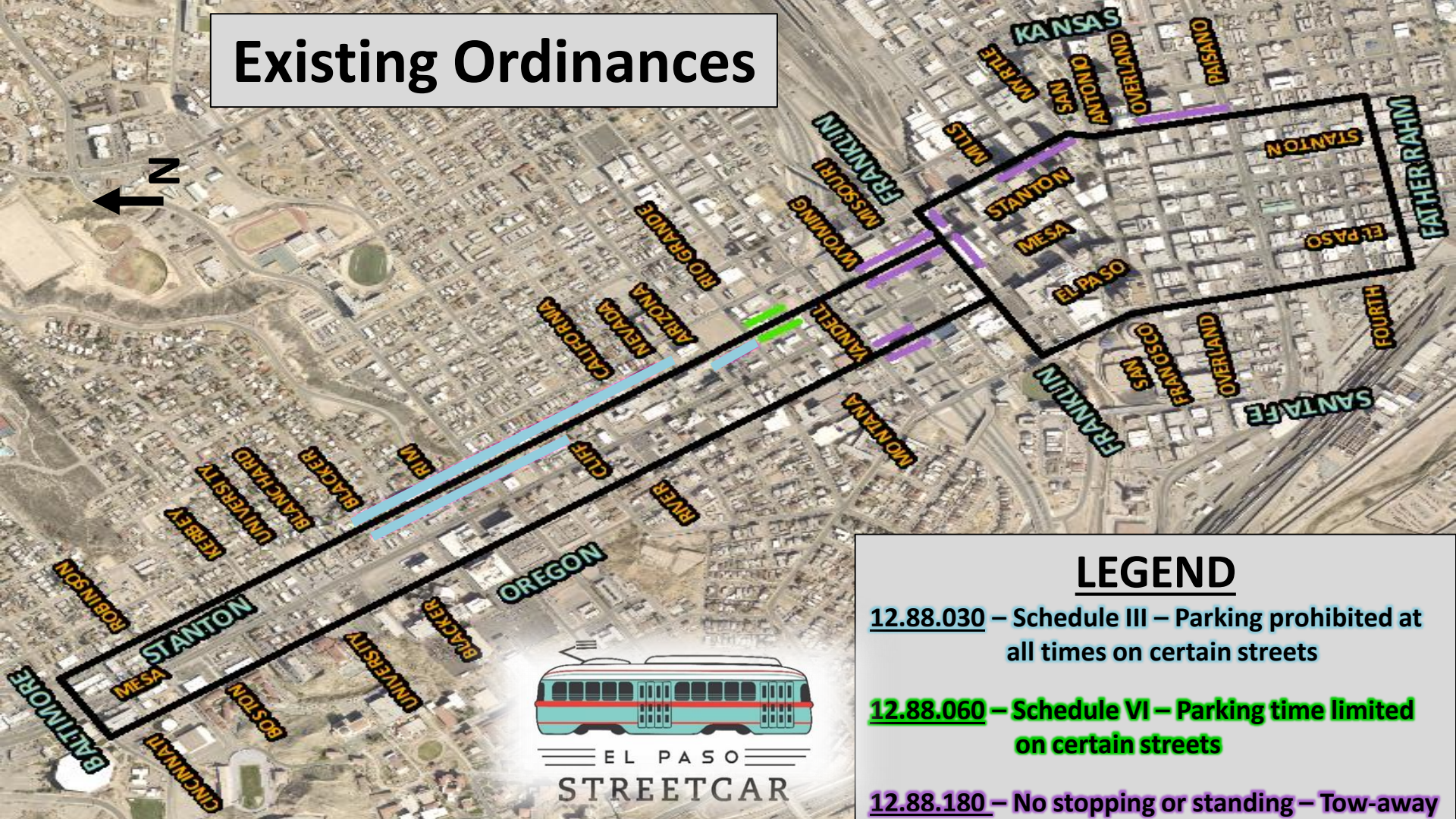

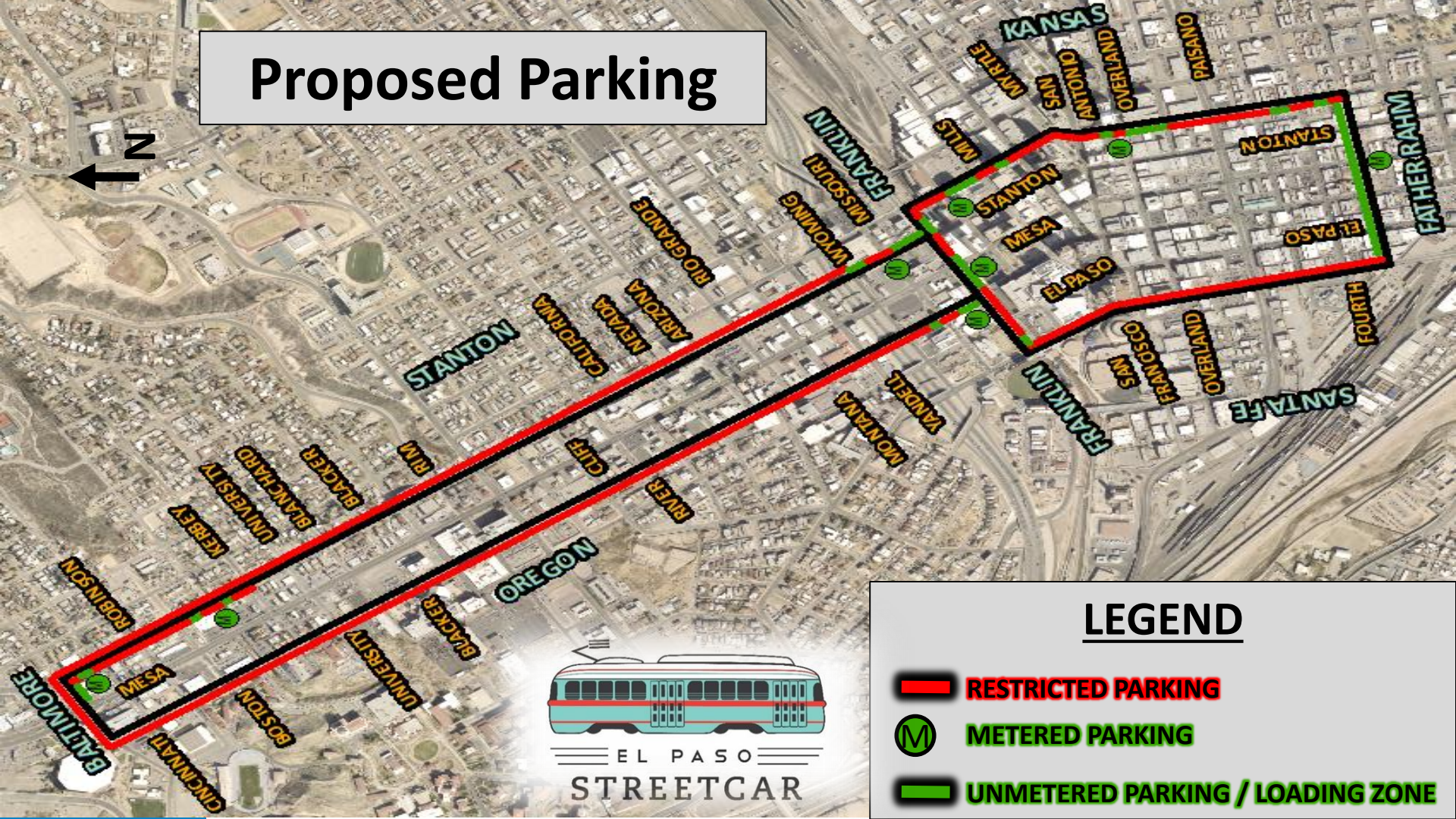

Requested Council Action

Via ordinance amendment...

DELETE:

12.88.030 – Schedule III – Parking prohibited at all times on certain streets

- 24. Stanton Street between Blacker Avenue and Cliff Drive, west side;
- 27. Stanton Street between Nevada Avenue and Blacker Avenue, east side;
- 129. Stanton Street between Rio Grande Avenue and Arizona Avenue, west side only;

12.88.060 – Schedule VI – Parking time limited on certain streets

Subsection A.

- 8. Stanton Street, both sides, from Montana Avenue to Rio Grande Avenue;

12.88.180 – No stopping or standing- Tow-away zone

Subsection A, subsections:

- 23. Kansas Street between Mills Avenue and Myrtle Avenue, west side;
- 35. Oregon Street between Yandell Drive and Wyoming Avenue, both sides;
- 53. Franklin Avenue from Kansas Street to a point 160 feet west thereof, south side;
- 56. Franklin Avenue between Mesa Street and Stanton Street, south side;
- 86. East side of Kansas Street between Overland Avenue and Paisano Drive

AMEND:

Subsection E, subsection 1 **to read:**

- 1. Stanton Street, both sides, from Sixth Avenue to Wyoming Avenue;

Requested Council Action

Via Ordinance, amend Title 12 (Vehicles and Traffic), to create a new chapter 12.90 (Parking Restrictions Along Streetcar Route) to regulate parking along the El Paso Streetcar Route. The penalty is as provided in the new chapter 12.90.

Chapter 12.90 includes the following Sections:

- 12.90.010 Definitions
- 12.90.030 – No Stopping, Standing, or Parking – Tow-Away zone
- 12.90.050 – Designated Parking Areas Along Streetcar Route
- 12.90.070 – Enforcement
- 12.90.090 - Penalty

Proposed Parking Amendment

Chapter 12.90 – Parking Restriction Along Streetcar Route:

12.90.010 Definitions

- A. Designated Parking Area(s)
- B. Streetcar
- C. Streetcar Route
- D. Traffic Engineer

12.90.030 – No Stopping, Standing, or Parking – Tow-Away zone

- A. When signs are erected an/or the curb is painted yellow giving notice thereof, no person shall at any time stop, stand, or park a vehicle on any side of a street within the Streetcar Route

Proposed Parking Amendment *continued...*

12.90.050 – Designated Parking Areas Along Streetcar Route

- A. Parking permitted within Designated Parking Area
- B. Parking in boundaries of Designated Parking area
- C. Parking in boundaries of Designated Parking area with meters

12.90.070 – Enforcement

- A. Traffic Engineer authorizations
- B. Police Department authorizations

12.90.090 – Penalty

- A. Towed vehicle
- B. Fine not to exceed \$500
