AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC) CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING-TOW AWAY ZONE), SUBSECTION A. AND SUBSECTION E. TO DELETE PARKING RESTRICTIONS ON KANSAS STREET BETWEEN MILLS AVENUE AND MYRTLE AVENUE, WEST SIDE; OREGON STREET BETWEEN YANDELL DRIVE AND WYOMING AVENUE, BOTH SIDES; FRANKLIN AVENUE FROM KANSAS STREET TO A POINT 160 FEET WEST THEREOF, SOUTH SIDE; FRANKLIN AVENUE BETWEEN MESA STREET AND STANTON STREET, SOUTH SIDE; EAST SIDE OF KANSAS STREET BETWEEN OVERLAND AVENUE AND PAISANO DRIVE; AND ON STANTON STREET, BOTH SIDES, FROM EIGHTH AVENUE TO WYOMING AVENUE. THE PENALTY BEING PROVIDED IN CHAPTER 12.84 OF THE EL PASO CITY CODE.

**BACKGROUND / DISCUSSION:**

The purpose of this amendment is to, in support of the El Paso Streetcar, regulate parking along the streetcar route; support new infrastructure and operations; allow towing of illegally parked vehicles; identify designated parking areas along the route; and delete and consolidate existing ordinances along the route.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING-TOW AWAY ZONE), SUBSECTION A. AND SUBSECTION E. E. When signs are erected in the following locations reading substantially "No Parking or Standing, 2:00—6:00 a.m., Tow-Away Zone," no person shall park or stand any vehicle on the following parts of streets between 2:00 a.m. and 6:00 a.m. on any day, including, but not limited to, Sundays and holidays:

1. El Paso Street, both sides, from Sixth Avenue to Wyoming Avenue.

**SECTION 7.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.




