# El Paso Mobility Coalition (EMCo) Executive Summary

The El Paso Mobility Coalition (EMCo) is community led initiative, housed at the El Paso Chamber, to advocate for highway, transit, and freight rail funding for the El Paso Metropolitan Area. EMCo members include the El Paso Chamber, the City of El Paso, the transportation construction and supply industry, consulting engineers and other interested organizations.

#### Purpose:

To identify and advocate for funding of multi-modal transportation solutions for the El Paso Metropolitan Area.

#### Goals:

- Support the development and implementation of adequate transportation infrastructure solutions for the El Paso Metropolitan Area that will support and promote growth in the El Paso Metropolitan Area.
- Identify and coordinate transportation infrastructure improvements for the El Paso Metropolitan Area in partnership with appropriate government and business entities.
- Utilize all available resources toward leveraging additional local, state, and federal transportation funds.
- To publicize that adequate and sustained local (including private sector donations), state and federal funds are essential for improved mobility.
- To develop broad base support for transportation system improvements.

Without a vibrant transportation system, all sectors of El Paso's economy and quality of life will suffer. Inefficient transportation leads to escalated prices of goods, increased costs of labor and reduced quality of life. By comparison, an efficient system preserves mobility for workers, businesses, residents, emergency responders and tourists – a level of mobility that expands opportunities for commerce, reduces environmental impact and enhances freedom of movement. Additionally, proper transportation planning and advocacy help steer development and transform underperforming areas of a community.

It is critical that El Paso fight for its share of transportation infrastructure dollars. Other Texas cities have been successfully doing so for many years. For the future of El Paso, we cannot afford to stand on the sidelines.

  - Northeast Expressway
- Identify and pursue all funding sources (local, state and federal)
- Pursue a "metropolitan" designation for TxDoT's Western District
