I. Discussion and action on requesting \$100,000 for MHMR every year from CDBG funds.

Summary:

Bill Lilly, Director of Community Development, stated that MHMR competes like every other agency on an annual basis for funds and they have received funding directly or indirectly for the program on an annual basis. Every summer the City Council adopts a set of polices and procedures that provide the policy direction to the Community Development staff for that particular program year. All funds for public services have been committed in accordance with that direction; the 15% allowable allocation for public services has been met. Therefore, there are no CD funds that can be allocated to MHMR at this time. In the future, if the City desires to allocate \$100,000 from the total public service amount allowable under the regulations they can consider that next year when considering Policies and Procedures for the coming year.

Action Taken:

The LRC voted 4 -0 to direct the staff to review the amount of funds that have been allocated to MHMR since 2003 and determine as per the contract between the City, County and Hospital District, if the City owes MHMR any additional funds.

Items 3 through 6 were read in together. William Lilly, Director of Community Development, spoke on the items followed by questions and comments from Representative Acosta, Holguin, Robinson and O'Rourke. Gary Larcenaire, CEO of MHMR, spoke as well as Selena Quintana, CFO for MHMR, Judge Anthony Cobos, County Attorney Rodriguez and MHMR Board Chair Richard Holt.

Public Comment was taken at 9:37am with the following speaking: Alfredo Perales, Julio Juarez & Roberto Parra

Motion made by Representative O'Rourke, seconded by Representative Robinson to clear up the terms of the interlocal agreement regarding the MH/MR and that the City Manager or designee and Mr. Gary Larcenaire or designee come to an agreement on what, if anything, the City still owes for the amount to come before council for approval.

Summary:

David Almonte stated that currently the City has an Employee Assistance Program in place that expires in December 2010. The contract is for \$22,000 dollars annually. City Manager, Joyce Wilson is not sure if this entity is exempt from going through the competitive process to compete for award.

Action Taken:

The LRC voted 4-0 to direct staff to review and determine if there is an inneragency arrangement that would allow the City to accept an unsolicited proposal that meets the City's needs and is equally cost effective. This action was to be brought back to City Council if need be.

III. Discussion and action on whether to deed the City building that houses MH/MR (3410 Morenci Ave.) to MHMR.

Summarv:

Gary Larcenaire, CEO of MHMR, stated that an analysis of the building condition, accompanied by a cost estimate, should be performed to determine whether it should be demolished and rebuilt. He also stated that the MHMR is not interested in having the property deeded to MHMR.

City Manager, Joyce Wilson suggested that the asset could be disposed of and the funding, including relocation assistance, could be provided to MHMR in its place.

Action Taken:

The LRC voted 4-0 to proceed with termination of the Interlocal Agreement between the City of El Paso and MHMR but the LRC would be willing to look at funding in the future if the County is not able.
