

# Coordination with FTA/TxDOT State Safety Oversight Agency

- As established under the current federal regulations, the FTA/TxDOT SSOA have safety jurisdiction over ALL rail transit in their states
- SSOA must approve operational plans before the start of revenue service
- TxDOT scheduled a site visit Sep 6 8, 2017 for a briefing and an initial inspection of the streetcar system
- TxDOT requested several plans which we submitted on October 31, 2017, and are expecting comments and additional documents request soon
- Awaiting PCC car and Maintenance Facility documents from Granite and Brookville
- SSOA safety certification is expected Aug/Sep 2018, which is necessary to start revenue service



### Marketing Plan for Safety Signage and Initial Outreach

- CRRMA is producing video/brochure for Safety Campaign
- CRRMA is preparing power points, handouts, brochures, onsite signage and other safety materials to address ADA, pedestrian, vehicular, bicycle, OCS poles, and streetcar interaction
- Sun Metro and CRRMA will conduct safety presentations with surrounding Neighborhood Associations/Civic Groups
- Sun Metro will schedule safety campaign meetings for each side of town to include: corridor maps, project timelines, fact sheets and grand opening information
- COEP will be selecting a marketing firm to assist in streetcar branding and possible naming rights, and fare sponsorship for special free day events



## **CRRMA and COEP**Transition Timelines

- CRRMA is responsible to construct the Streetcar system
- Hand-off to the COEP will be incremental as infrastructure and PCC cars are certified operational
  - Maintenance facility should be completed for hand-off in Jan 2018
  - Electrical and rail Infrastructure should be completed for hand-off early 2018
  - 1st PCC car should arrive late Jan/early Feb and be certified for hand-off in late Feb/early Mar
  - PCC cars 2-6 will arrive one-by-one, between Mar and Oct 2018
  - Revenue service projected to start in Nov 2018



### Other Streetcar Activities

- A PCC Streetcar wrapped bus will be displayed at Winterfest starting Dec 1<sup>st</sup>
- Sun Metro will provide free rubber tired trolley transportation at Winterfest on Fri, Sat and Sun during peak times
- The CAC met on Nov 21<sup>st</sup> to discuss the naming of the Maintenance Facility after the late Ron Dawson, who was instrumental in the operations and restoration of the El Paso streetcar system for over 40 years
- The streetcar team is planning a visit to Tucson to observe their streetcar system operations and marketing efforts
- Sun Metro is working on incorporating the streetcar trip planning and real-time tracking to the upcoming fixed route real-time app for use on cell phones and computers
