- A. Except as otherwise provided by Texas state law, any person violating any provision of this title shall be deemed guilty of a misdemeanor and shall be punished by a fine not to exceed two thousand dollars.
- B. In addition to any penalties provided herein, this title is enforceable by injunction.
- C. If a person provides proof that she or he cured the violation prior to the first court appearance, the court may assess a defendant an administrative fee set forth in the fee schedule for each violation if a charge under this section is dismissed. Euthanasia of the animal or surrender of the animal to the department is not acceptable proof that the violation was cured.
