An ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking Prohibited At All Times On Certain Streets), Paragraph 379 (Weston Brent Lane), to amend the No Parking locations on Weston Brent Lane, the penalty being as provided in Section 12.84.010 and Chapter 12.85 of the El Paso City Code

BACKGROUND/DISCUSSION:

A property owner on Weston Brent has requested to remove the existing no parking ordinance to allow parking on Weston Brent because property owner's business parking demand has outgrown his parking lot. The property owners that originally requested the no parking restriction reject this proposal due to safety concerns over visibility when exiting their parking lots. After public meetings, a consensus was reached to allow three parking spaces on the south-side of Weston Brent closest to Lee Trevino. This option is what is being considered by Council today.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III – PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS), PARAGRAPH 379 (WESTON BRENT LANE), TO AMEND THE NO PARKING LOCATIONS ON WESTON BRENT LANE, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets), Paragraph 379 (Weston Brent Lane), is hereby amended to read as follows:

12.88.030

379. Weston Brent Lane, between Trawood Drive and Lee Trevino Drive, northeast side and Weston Brent Lane between Trawood Drive to a point 245 feet west of Lee Trevino Drive, southwest side;

Section 2. Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.




