## **SUBJECT: RESOLUTION**

This resolution establishes that the period of January 5 to January 16, 2015 be declared Food for Fines period for the El Paso Public Library ("the Library") to waive \$1.00 worth of fines for every canned or non-perishable food donation made to the Martin Luther King Canned Food Drive at Library locations up to \$5 per day provided all materials are returned in good condition; as defined in the Library Rules and Fee structure.

# BACKGROUND / DISCUSSION:

Ordinance No. 15006, approved by City Council on December 24, 2001, authorizes Council to declare limited periods of "Amnesty" to allow borrowers of items from the El Paso Public Library to return overdue items or items previously considered lost, without payment of the applicable overdue fines or fees for the lost item.

#### PRIOR COUNCIL ACTION:

Council approved a Food for Fines period in January 2012, January 2013, and January 2014. The last Food for Fines period was in January 2014. 1,366 lost items were returned with a material worth of \$23,361.57. The Library also collected an estimated four tons of food.
