General Services recommends utilizing HGAC Contract VE11-13 to issue a purchase order to Silsbee Ford, Inc. for six (6) Ford F-150 XL Super Cab Pickups in the amount of \$115,830.00.

1. Is there an urgent need for the product/service? In other words, is time of the essence?

Yes. These trucks will be used by City Inspectors in the City Development Department to conduct inspections throughout the City. There are currently more inspectors than there are vehicles.

Yes. The purchase will support local business indirectly as all warranty and non-warranty issues will be handled locally. The decision to purchase from this vendor came as a result of an existing vehicle contract that is not in compliance with the City's pricing clause and the non-availability of a local vendor on a Cooperative Contract.

4. Do the available vendors have prior work experience and/or familiarity with the City?

No.

5. Is the pricing reasonable as compared to other similar products/work performed for the City of El Paso in the past or as quoted from other companies?

Price reasonableness has been established because the cooperative purchasing agency used a competitive bidding process in the awarding of the contract.
