#### **BACKGROUND / DISCUSSION:**

The term of the Public Service Board member (Mr. Bradley Roe) serving in the Engineering category expires on December 31, 2018. On November 13, 2018, as required by Ordinance Number 017167, the El Paso Water Utilities Public Service Board Selection Committee (hereinafter "Selection Committee") met and reviewed the applications submitted by qualified applicants. The Selection Committee's membership consists of the Public Service Board and seven persons (1 vacancy) appointed by City Council Representatives. After deliberation, the Selection Committee selected three candidates and ranked the three candidates in order of preference for this position. The Selection Committee's recommendation is being forwarded to City Council for their consideration and appointment.

Advertisements for applicants interested in this position were placed in the El Paso Times and the El Paso, Inc.

#### **PRIOR COUNCIL ACTION:**

#### Has the Council previously considered tis item or a closely related one?

Yes. The City Council most recently approved a Resolution on November 14, 2017 re-appointing board member Christopher Antcliff to fill a second term on the El Paso Water Utilities Public Service Board of Trustees.

#### AMOUNT AND SOURCE OF FUNDING:

The El Paso Water Utilities Public Service Board is funded through the budget of the El Paso Water Utilities.

#### **BOARD/COMMISSION ACTION:**

On November 13, 2018, the Selection Committee approved a Resolution selecting and ranking the three most qualified candidates in the area of expertise in Engineering. The Committee's Resolution is attached.

#### RESOLUTION

WHEREAS, a vacancy in the El Paso Water Utilities Public Service Board of Trustees will occur on December 31, 2018 with the term expiration of board member Bradley Roe, who filled the board position which required expertise in the area of Engineering; and

WHEREAS, the City of El Paso adopted Ordinance Number 017167 which requires that any vacancy in the membership of the El Paso Water Utilities Public Service Board of Trustees be filled by the City Council; and,

WHEREAS, the City of El Paso by Resolution established the El Paso Water Utilities Public Service Board Selection Committee, to be comprised of the members of the Public Service Board and such additional members as appointed by the City Council to assist City Council in selecting eligible candidates to fill the vacancy; and,

WHEREAS, under the Resolution, the El Paso Water Utilities Public Service Board Selection Committee reviews resumes submitted by persons interested in filling the vacant position and submits to the City Council the names and the ranking of three eligible candidates;

### NOW THEREFORE, BE IT RESOLVED BY THE EL PASO WATER UTILITIES PUBLIC SERVICE BOARD SELECTION COMMITTEE OF THE CITY OF EL PASO, TEXAS:

THAT, a quorum of the El Paso Water Utilities Public Service Board Selection Committee met on November 13, 2018 pursuant to the Texas Open Meetings Act and approved the nomination, ranking and recommendation to the City Council of the following candidates to fill a vacancy on the El Paso Water Utilities Public Service Board of Trustees:

- 2. Bryan R. Morris, P. E.
- 3. David Dodge

THAT, the El Paso City Council hereby appoints \_\_\_\_\_\_to fill the vacancy on the El Paso Water Utilities Public Service for the position with expertise in the area of Engineering. The Term of appointment shall commence on January 1, 2019 and shall be for a four (4) year term.

My career started as a Structural Design Engineer in 1965, with the structural division of the Featherlite Corporation in El Paso, eventually becoming Chief Engineer and Plant Manager. While with Featherlite I developed and implemented the Quality Control Program for several different Featherlite Precast Prestressed Plant operations. This lead to being appointed to the Prestressed Concrete Institute PCI Committee to develop a national Manual for "Quality Control for Plants and Production of Precast Prestressed Concrete Products", known as MNL-116, first published in 1970. (1965 - 1976)

Joined J.D. Abrams Construction, in the mid- 1976, later becoming Vice President and Operations Manager, for transportation and heavy civil projects. These projects ranged in size up to \$50M, for various DOT's and Corps of Engineers projects. Responsibilities include upper level management for, project management and engineering, assigning office and field personnel, equipment utilization, and project scheduling, for major engineered projects related to airports, roads and bridges, earthwork, flood control, and drainage projects. During this time I held Contractor's Licenses in the states of New Mexico and Louisiana, as well as Professional Engineering Licenses in the states of New Mexico, Texas, Arizona, and Florida. Responsibility included being in charge of construction for major flood control and drainage as well as bridge projects in Texas and New Mexico, and major bridge projects across the Southeastern United States. These projects include Major highway interchanges as well as a ship channel crossing utilizing segmental construction.

In 1988 I retired from J.D. Abrams and after a short time began work with Parkhill, Smith & Cooper, as the Construction Manager for the company. Serving in this capacity until retirement in 2012. During my career I have been responsible for design, project management, project budget and cost control, and over-sight for over 1 Billion Dollars of construction work.

My 23 year career at PSC began in 1989 with the construction oversight and inspection of the Bustamante WWTP, continuing with construction of the Jonathan Rogers WTP, the Jonathan Rogers WTP addition, Haskell Street Pump station and the Clary Fox Drainage Project. As part of this science fair project we installed a hot water recirculating system in our house that we still use today. My family and business are active participants in recycling. I vividly remember August 1, 2008 standing on Silver Springs, on the Westside, and watching the flood down that street. I support El Paso Water being in charge of storm water.
