## SUBJECT:

Approve a Resolution authorizing the City Manager to sign Lessor's Approval of Assignment between the City of El Paso ("Lessor"), Golf Management, Inc. ("Assignor") and Bueno Investment, Inc. ("Assignee")

## BACKGROUND / DISCUSSION:

The City of El Paso currently has a Golf Course Operation and Concession Agreement with Golf Management, Inc. to operate the Lone Star Golf Club golf course. Golf Management desires to assign the agreement to Bueno Investments, Inc. Bueno Investments will become liable to pay any and all sums owing or becoming due Lessor under terms of the Golf Course Operation and Concession Agreement, and agrees to accept and abide by all the terms, covenants, and conditions of the Golf Course Operation and Concession Agreement. In addition, Benjamin A. Vanecek, president of Bueno Investment, Inc., guarantees payment, as an individual, of rents and other charges or fees due to the Lessor and shall remain fully liable for the prompt and complete performance of any and all obligations arising, or to arise, under the Golf Course Operation and Concession Agreement.

The agreement has an effective date of April 1, 1985 with the term to expire March 31, 2026. There is one (1) option for one additional term of five (5) years, which if exercised would expire on March 31, 2031.

#### PRIOR COUNCIL ACTION:

The Golf course Operation and Concession Agreement was approved by City Council on April 1, 1985, and Council further approved five (5) amendments to the Concession agreement the last of which occurred on September 2, 2008.

The City of El Paso ("Lessor") entered into a Golf Course Operation and Concession Agreement Cielo Vista Municipal Golf Course dated April 1, 1985 ("Concession Agreement") between the Lessor and John William Eschenbrenner; which was subsequently assigned to Golf Management, Inc. ("Assignor") pursuant to Section 11 of the Concession Agreement; amended by the execution of the First Amendment to Golf Course Operation and Concession Agreement with an effective date of April 1, 1991; further amended by the execution of the Second Amendment of Concession Agreement with an effective date of June 1, 2000; further amended by the execution of the Third Amendment of Concession Agreement dated April 30, 2002; further amended by the execution of a Fourth Amendment to Golf Course Operation and Concession Agreement with an effective date of August 9, 2004; and subsequently amended by the execution of a Fifth Amendment to Golf Course Operation and Concession Agreement with an effective date of September 2, 2008 (collectively referred to herein as the "Concession Agreement") covering the following described leased premises:

A portion of Morehouse Survey No. 12 and a portion of Section 40, Block 80 TSP 2 T&P Survey, City of El Paso, El Paso County, Texas, being more particularly described in **EXHIBIT A**, attached hereto and made a part hereof, and municipally known as Lone Star Golf Club (f/k/a Cielo Vista Golf Course) located at 1510 Hawkins Blvd., El Paso, Texas ("Premises").

- 1. <u>CONSENT TO ASSIGNMENT</u>. Lessor hereby approves and consents to the assignment of the Concession Agreement from Assignor to Bueno Investments, Inc. ("Assignee"), on the condition that Assignee assumes and becomes liable to pay any and all sums owing or becoming due Lessor under the terms of the Concession Agreement from and after the effective date of the assignment of the Concession Agreement to Assignee, and upon the further condition that Assignee agrees to accept and abide by all the terms, covenants, and conditions of the Concession Agreement.
- 2. PROOF OF INSURANCE AND INDEMNIFICATION. Assignee has provided a certificate of insurance to evidence compliance with the insurance requirements of the Concession Agreement and expressly agrees to be bound by the indemnification provisions contained in the Concession Agreement.
- 3. GUARANTOR. Assignor shall be released and discharged from all rights, privileges and obligations under the Concession Agreement arising from and after the effective date of the assignment of the Concession Agreement and Assignee shall, as of the effective date of the assignment, enjoy all rights and privileges and be responsible for satisfying all such obligations the same as if the Concession Agreement had originally been executed between Lessor and Assignee, contingent upon the execution of a Guaranty of

Assignment by Benjamin A. Vanecek ("Guarantor"), Individually, which guarantees payment of rent and other charges or fees due to the Lessor and provides that Guarantor shall remain fully liable for the prompt and complete performance of any and all obligations arising, or to arise, under the Concession Agreement.

- 4. RATIFICATION OF CONCESSION AGREEMENT. Except as expressly modified herein, no provision of this consent alters or modifies any of the terms and conditions of the Concession Agreement; all other terms and conditions of the Concession Agreement shall remain in full force and effect.




