AN ORDINANCE AMENDING CHAPTER 12.56 (PARKING METERS) OF THE EL PASO CITY CODE TO CHANGE THE REFERENCES TO THE DEPUTY DIRECTOR OF STREETS TO INTERNATIONAL BRIDGES DIRECTOR; THE PENALTIES BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

WHEREAS, the CITY OF EL PASO, ("City") on August 19, 2008, adopted Ordinance Number 016969 which created the International Bridges Department; and

WHEREAS, on August 19, 2008, the City assigned the duties and services relating to areas of parking meter concerns, as determined by the City Manager, as functions of the Department of International Bridges; and

WHEREAS, on July 30, 2002, the City adopted Ordinance Number 015157 which granted authority to the Deputy Director of Streets to install and maintain parking meters, set parking fees and provide for use of parking meter fee debit cards.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

That all references in Chapter 12.56 of the El Paso City Code, to the term "Deputy Director of Streets" shall be substituted with the term "International Bridges Director".
