WHEREAS, pursuant to Section 31.11 (c-1) the governing body of the taxing unit may extend the deadline for a single period not to exceed two years on a showing of good cause by the taxpayer; and

WHEREAS, taxpayer, Jose and Ana Munoz through Capital Title of Texas, LLC Plano ("Taxpayer") has applied for a refund with the tax assessor for their 2012 property taxes that were overpaid on April 30, 2013 in the amount of \$70.98 for all taxing entities; and

WHEREAS, City Council may extend the deadline for the Taxpayer's application for the overpayment of the 2012 taxes for a period not to exceed two years on a showing of good cause by the taxpayer; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

The Internal Audit Office conducted a review of the Tax Overpayment Refunds that exceed a three-year period. 
