- 1. Call to Order. Meeting started at 10:01AM
- 2. Roll Call. Quorum. 7 of 8
- 3. Discussion and Action to Approve Minutes of: March 18, 2022. Approved
- 4. Citizen Comment Period: Individuals limited to 3 minutes; no specific action may be taken
 - a. John Martin Opportunity Center for the Homeless: Raised 50% of the funds required for the new Veterans Transitional living center. Total cost \$2.7M. There will be an event to promote the VTLC on April 30, 2022 at the VFW post 812. The address of the VTLC will be on the 1200 block on Magoffin Ave
 - **b.** Sarah Kamalipour VA caregiver support program: Two programs; A stipend program and a resource program. Sarah can be reached at 915 564-7522. 915 564-6100 ext 6050.
- 5. El Paso VA Health Care Clinic Update Associate Director –Blanca Aragon Nurse Executive
 - a. COVID Boosters are offered for anyone 50 years of age and over. Administered Tuesday and Thursdays at the main clinic and satellite clinics. There are new programs for whole health coming on board soon. VA will hire two Chiropractors; have programs that provide Acupuncture, Healthy living, tobacco sensation,

Health Coach... and more. Located on 2nd floor as a part of the Whole health team.

- b. VA will provide transportation. Need to call in advance and will be picked up from home if referred to WBAMC or other specialty care. The demand for WBAMC transportation is low. Veteran Transportation Service (VTS) 915-564-6114. First come, first served. Qualify as long as they are going to a scheduled appointment at any VA facility or community provider VA has referred the patient to. First pick up at 0630 and last scheduled drop off 1530. Las Cruces area is also serviced
- **c.** There are still nationwide shortages of prosthetic devices. Last month's update: The VA has experienced a delay with the delivery of prosthetic devices, wheelchairs, scooters, braces, canes ect... Supply chain issues are causing delays. Please call 915 564-6100 ext 7961. If anyone is experiencing issues they can reach out and receive an update on delivery.
