- 1. Call to Order. Meeting started at 10:01AM
- 2. Roll Call. Quorum. 8 of 9
- 3. Discussion and Action to Approve Minutes of: April 15, 2022. Approved

- 5. El Paso VA Health Care Clinic Update Interim Director Mike Rielo
 - a. The new Executive Director Mr. Froy Garza will arrive in the next 3 weeks. He is coming from Miami VA.
 - **b.** Money has been appropriated to start moving forward on the build for the new VA clinic. Proposals will be sent out for biding in August. This is a design build with one vendor.
 - c. Masks are still required at the VA. The El Paso VA is considered to be at a medium risk and will always announce requirements for entry into the facility.

 - a. El Paso County Veterans Advisory Board Chair update Alexis McCray.
 - i. Early voting is ongoing now
 - ii. The County Veterans Advisory Board has a vacancy, Please send recommendations to Carl Dwyer. Opening is for Precinct 3 and the Veteran is recommended to reside in that precinct.
 - iii. The VAB has changed the eligibility for Veteran of the Year. Residence is no longer required. Applications are currently being accepted.
 - iv. Women Veterans day will be recognized by the County at Ascarate Park on June 10th at 9am
 - v. The Veterans Business Association is hosting a Golf tournament on May 21, 2022 at Painted Dunes Golf Course.
 - vi. Armed Forces Day Parade is on Ft. Bliss on May 21st at 10AM
 - vii. EPVRA and Shammaly Ford on May 22nd at 10AM
 - viii. Veterans at Breakfast will meet at the Veterans One Stop May 26th at 0830. They meet every last Thursday of the month and looking for a new leader. 50 years of age and younger is preferred.
 - **b.** El Paso Coalition for the Homeless update- Camille Castillo no update. Not present.

 - **a.** Victor Casas District 1 is assigned to the Employment and Homelessness sub committees.
- 9. Discussion: Subcommittee Chairs update on assigned focus areas.
 - a. Bruce Biegel Employment- Achieved most all goals that have been presented to the City. Currently working to share these strategies with the municipality. Lance wants to use the We Hire Vets recognition to promote veteran Employment. He wants to pursue funding opportunities for the DOL Veteran Employment Program. Justin Rotti wants to find ways to bring Veteran friendly companies to move to El Paso. Laura wants to add the Borderplex Alliance to the conversation. Paul Albright will set up a meeting with the Economic Development department to learn how to bring Veteran Friendly organizations to El Paso. He also mentioned having a recognition ceremony for Businesses that hire Veterans. Lance asked about how to help Veteran start –ups. This conversation with the City is ongoing. The City is building a 150,000 Sq ft innovation factory for Start ups.
 - b. Melissa Harcrow Homelessness- the Subcommitte had a great meeting which included members from the City Community Development. How will the repel of Title 42 effect Veteran Homelessness efforts. Question was not answered. The Conversation turned to how to reinstate someone that was blacklisted from a shelter to allow them to return.
 - c. Rodney Washington Marketing and Outreach- Laura Butler briefed that they will have a meeting and talk about how to hold a meeting to move forward on goals set forth by the subcommittee.

- a. Texas Veteran Network Regional manager is Martha Garza and she is located on Ft. Bliss. Works with Combined Arms to provide resources to Veterans across the State. Will bring Combined Arms to brief the VAAC.

- c. Will begin working on the Veteran Resource page to update all of the information.
- **d.** The City has three IGSA's. Ft. Bliss just asked about putting together a 4th IGSA for Hazardous waste.
