- 2. Roll Call. Quorum. 7 of 9
- 3. Discussion and Action to Approve Minutes of: May 20, 2022. Approved

- 5. El Paso VA Health Care Clinic Update Interim Director Tracey L. Arensmann
 - a. The new Executive Director Mr. Froy Garza started on June 6th.
 - b. There is progress with the new facility, preparing to put the solicitation for bids out and will send update by email to Paul and everyone. Yes, this is a design build with one vendor, it will be unique. Need to bring over the lines and everything from Beaumont and loop. Permits and everything in place, progressing nicely.
- 6. El Paso County Veterans Assistance Program Manager Carl Dwyer.
 - a. El Paso County Thanks for all that participated and involved on this month's Women's veteran's recognition across the county and the city. Spotlighted women veteran and how El Paso putting minds together can recognize veterans.

- a. El Paso County Veterans Advisory Board Chair update Alexis McCray.
 - i. County closed on Monday in celebration of Juneteenth.

- **b.** El Paso Coalition for the Homeless update- Camille Castillo Not present. Email sent to Melissa Harcrow with updates.
 - i. On June 10th: 66 homeless veterans, 22 unsheltered veterans, 44 sheltered veterans.
 - ii. Past 90 days: 46 veterans exited to permanent housing.
- Discussion and Action: Assign new Committee members to Subcommittees All assigned.

- a. September/October briefing need to focus on moving forward from where we are at, to getting after the things we really want to do in the future and taking a look at strategic plan and see where needed to be plug in.
- 9. Discussion: Subcommittee Chairs update on assigned focus areas.
 - a. Bruce Biegel Employment- Achieved most all goals that have been presented to the City. Currently working to share these with other employers in El Paso. Tentative plan that consists of five main parts
 - Leveraging the states hiring vets, recognition award and digital sticker.
 Will ask state for more local engagement visibility. Will recommend representative to be local under TVC or TWC
 - ii. Attractive Vet through friendly businesses to the El Paso area VAC should partner with Borderplex to assist in attracting veteran military spouse friendly from the employers. Partner with TX Veterans Commission, TWC and workforce solution to assist with veteran hiring, virtual or in person at different facilities.
 - iii. Training program for hiring managers in person or virtually
 - iv. Public recognition by the mayor and/or City Council to employers that are being successful in the hiring and retention of veterans to military spouses. Can use the states hired veteran's recognition program as a benchmark done either cities' annual veterans' luncheon or city council meeting.
 - v. Ensure veterans' spouse are part of any outreach and veteran employment focus due to the rate of unemployment among military spouses.

Bruce, Laura and Rodney will talk about how the city can affect as part of the overall plan in the next meeting. Lance will work to get the mayor to approve for the luncheon and the city council meeting, council would be more powerful and second to get into the luncheon. Need to breakthrough to employers to understand that it is thinking they are going to leave in two, three years, it is the skills and abilities that they will bring to the business.

b. Melissa Harcrow – Homelessness- the Subcommittee had a great meeting. Victor Casas attended and a quick rundown was given on mission and goals; the attendance to the Master list meeting. He should be attending next month. Jonathan will attend this month's meeting. Jonathan brought up the homelessness stand down and its one meeting a month. Rodney attends and Melissa will try to attend. Alexis McCray would like to schedule a roundtable with elected officials, head of agencies, trying to make our leaders aware of these hardships that are in place and slowing down our progress. Currently unaware of how many homeless veterans we have, not only VA qualified. Hand on VA's requirement, policies and procedures from 2017. Get together and fine tune these requirements and discuss How we can further make progress in our homelessness? Abraham Gutierrez, assistant director from Community and Development, would like to setup meeting with homelessness subcommittee, include Ms. McCray. Need to get consistency and clarification for the master list. CD would be able to facilitate virtual meeting. Meeting will be setup by CD. requested email from Ms. McCray, Melissa will attend. Jonathan, agrees great

- meeting to include crisis intercept mapping, if there is a gap a flow chart could be given.
- c. Rodney Washington Marketing and Outreach- Last month event, two weeks of 20+ employers to include Microsoft, Oracle, OHS, Park and Wildlife and several top-rated employers state, local and international. They did showcases trying to help us connect people in El Paso area to include West Texas with new job opportunities. Had over 1,300 people that participated. Way to get these events out there to the local community so that we can have more people to attend. There were people at job fairs attended to include the Women's veteran's day on Saturday and a lot of people were not aware of the veteran's committees. How to make the community aware. Not sure if can be done on Facebook or Instagram. Lance agrees there has to be advertising beyond our website or Facebook, the city will do this for us. Mr. Albright has requested funding for advertising. Subcommittee needs to concentrate on how to get the word out, with lowest cost and the most return of investment that we can get. Best role and how do we team up with people that want to support: Borderplex, County, City? How do we pull a team together? Bruce suggested the City in 5 done by the city, maybe a 30 second to have the VAC speak a week before the set meeting. Jonathan, regarding the job/career portion and transitioning, VA has started a sponsorship program for transition service members that will help with the transition of service members and their families. Not available in El Paso yet, only Dallas or Austin. Sun City Bliss has been the way that been advertising. Rodney contact city to get 32 second on City on 5.
