Cecilia Mungaray (HR) ~Employment

Job postings no longer have the words "must have" They now have language that states minimum specifications or the word "preferred". Working to meeting the 20% hiring rule. City of Houston and Laredo had to create a City Charter change to implement the policy. Veterans are now identified to department Directors on the Eligible list. Created an HR4Vets Program. This program provides assistance by reviewing resumes, applications, and the interview process. HR will provide input to the Veteran to help them to highlight their skills in order to maximize their chances for employment. Central HR will adopt these policies and programs and implement them across all departments. HR and the Chief Military Officer will be working with the legal team to push for a City Charter Change to implement a 20% hiring rule.

Mark Weber (CD) - Homelessness

Community development requested and received \$233,424 through the Home Investment Partnership Program to support Homeless Veterans. (Home Funds under HUD) This rental assistance will provide rent for 24 Veterans. The Veterans Permanent Supportive Housing Notice of Funding Availability (NOFA) will be released to the Community on September 14·2020. Applications will be due on October 12·2020. Announcement of the award will be on October 19·2020. The VAAC will be a part of the drafting and award process. A working group will be established that will assist in the development of the qualification criteria.

Jon Martin Opportunity Center – July 22, 2020 opened an HCHV Shelter under contract with the Department of VA. Can house up to 15 homeless Veterans. Currently 3 are housed. Each has a private room or a roommate. 61 Veterans have come through the Delta Center. That is 6.8% of the 895 Homeless Population. VTLC contract has been renewed. In September the OTC will start the Work First Employment initiative focused on the hard to employ that includes Veterans.

Motion to have the homeless subcommittee designate two personnel to sit with CD and prepare the NOFA and report back to the VAAC on a regular basis. Motion passes unanimously.

Anyone who helps develop this NOFA cannot also apply or bid for the funding. This will create a conflict of interest.

Soraya Ayub (PIO) – Marketing

Sun City Bliss for September highlights the efforts of the EL Paso VA, Veterans One Stop and The Steven A Cohen Military Families and Veterans Clinic. The Veteran Resource page is continuing to evolve. The City of El Paso Veterans and Military Affairs Facebook page is active. Future initiatives is to build fliers to spread the locations of resources for Veterans to receive information important to them. Lance and the Sub-committee on Marketing would like to schedule a meeting with PIO to further initiatives. Posters and fliers need to be on Ft. Bliss.

Motion and Second to rescind the last action approved dictating that only the Homeless subcommittee will serve on the working group and allow anyone on the VAAC to serve specifically Hope Jackson, Don Parrot, and Lance Lehr. Motion passes unanimously.

Hope Jackson and Don Parrott (Don is subject to approval from the TVC Compliance Department) will serve on the Working group to help develop the Veterans PSH NOFA. Lance Lehr will be a participant.
