- 1. Call to Order, 10:03AM.
- 2. Roll Call. 6/8 Quorum.
- 3. Discussion and Action to Approve Minutes of: September 24, 2021. Approved.
- 4. Citizen Comment Period: Individuals limited to 3 minutes; no specific action may be taken.
 - a. Mike Amaral concerned about the Hospital signs on HWY 54 and Fred Wilson. Concerned that someone may think there is a Hospital where one does not exist. Needs help in getting the signs removed.
- 5. El Paso VA Health Care Clinic Update Mike Amaral, Director.
 - a. Drive through Flu Clinic is available at Team C of the VA Clinic. Back to pre-COVID volume at the clinic. Encourage Veterans to use Tele-health if possible. The new clinic is moving along nicely. There is interested local contract companies to perform work on the site.
 - b. COVID Booster Shots are for Veterans that are immune compromised
 - c. Are Satellite Clinic giving flu shots on a walk-in basis? Yes
 - d. Have the different vaccination sites been merged? The City and VA have merged and account for all shots. About 51% of Veterans have been vaccinated.
 - e. Have there been any conversation about bus service to the new WBAMC? The VA is working with Sun Metro for a shuttle service.
- 6. El Paso County Veterans Assistance Program Manager Carl Dwyer.

- a. El Paso County Veteran of the Year ceremony will be on November 9 at 10AM.
- **b.** Veterans Parades: Fabens, San Elizario, Downtown El Paso and Northeast parades.
- c. Bel Air High School Veteran's Day recognition ceremony November 4th 10AM.
- 7. El Paso County Veterans Advisory Board Alexis McCray. Not present.
- 8. El Paso Coalition for the Homeless Camille Castillo.
 - a. EPCH has a new positon to oversee the VTLC collecting all data.
 - b. SSVF is implementing a shallow subsidy. Met with SSVF in the community to put a plan together to see what the subsidy will look like. It will be able to provide rental assistance over an expanded period. More than what is eligible under the regular program guidance. Up to 2 years and 35% of their awarded money. They anticipate that the VA will open that up to 50% within the next few months. EPCH put together a list of Veterans that will be targeted for these subsidies.
 - c. How many Veterans will be served by the Subsidies? 15 to 22 households.
- 9. El Paso Tenet Based Rental Assistance Program Quarterly update Nicole Ferrini.
 - a. 7 Active clients in July: 6 Active Clients in August; 3 Active Clients in September. October has 5 Active clients. The goal of the program is to house 20 Veterans by January 2022. 13 total clients served since inception 2 have been served with case management only.
 - b. Most of clients have reached most if not all of their goals. Most have their identifying documents. Case managers can get documents for those that do not.
 - c. All clients have been linked to employment agencies or stable jobs. All of the Active clients have been registered with mental health services and other veteran resources.
 - d. There were a number of clients that were not responsive to the program.
 - e. Is this program cost effective? Should we push to continue to push for this program? This program needs to run its course longer so that we can see if there is recidivism. Would like to get back to the VAAC after speaking with the provider of the program.
 - f. Do you anticipate adding 7 more veterans to the program before January? Has the case management been approved? Not sure if 7 more Veterans will come into the program. There may be conversations about extending the contract. Would like to meet with the Homelessness subcommittee and find a method to either extend the program or find a way to replicate or improve the program for the future.
 - g. Please explain what 11 housed and 2 under case management. 11 are housed and receive case management. 2 are not housed but receiving case management. Not sure if they are unhoused or housed under another program. Will follow up.

Endeavors is having a truck or treat on October 31st 2-4 PM.

Tephanie Hopper - Marketing and Outreach

Marketing: Would like to meet with DVMA and Strategic communication. Would like to see site updates, press releases and a logo. The websites need cleaned up. Need Headshots and a bio of VAAC members on the website. Add current Bylaws to the website. Would like to see if we can get billboards, benches, waste container advertising. Please schedule a meeting. Question Bruce: can marketing include suicide awareness? Answer: it was brought up, need to find a venue to get the information out there.
