- 8.1.1. EPE has settled with the City of El Paso and other intervening parties, pending final approval from the PUC. The residential impact will range between \$3.50 \$5.00 / month. For private solar residents, the provision stands that, effective after the final order, there will be a minimal bill of \$30. Anyone that already has an interconnection agreement at the time of the final order will be grandfathered in and the minimal bill will not have an impact. The net metering provision stands. EPE will share the information once it's available, in the last quarter of this year (anytime in the next few months).
