



Trends with younger homeowners







Student debt has little impact on homeownership rates long-term. Rather, having a college education, whether with or without debt, leads to higher rates of homeownership.



Fair Housing Act

Prohibits housing discrimination on the basis of race, color, national origin, religion, sex, familial status, and disability. A person who identifies as LGBTQ who has experienced (or is about to experience) discrimination under any of these bases may file a complaint with HUD. HUD is committed to investigating violations of the Fair Housing Act against all individuals regardless of their sexual orientation or gender identity.

Examples:

A transgender woman is asked by the owner of her apartment building not to dress in women's clothing in the common areas of the property. This may violate the Fair Housing Act's prohibition against sex discrimination, which includes discrimination based on non-conformity with gender stereotypes.

A gay man is evicted because his landlord believes he will infect other tenants with HIV/AIDS. This may violate the Fair Housing Act's prohibition against disability discrimination, which includes discrimination against people who have or are perceived to have HIV/AIDS.

LGBT Equal Access to HUD Programs

The U.S. Department of Housing and Urban Development enforces regulations that ensures its programs are open to all eligible individuals regardless of actual or perceived sexual orientation or gender identity.

HUD Equal Access Rule

HUD's Equal Access Rule requires equal access to HUD programs without regard to a person's actual or perceived sexual orientation, gender identity, or marital status. Housing providers that receive HUD funding or have HUD-insured loans are subject to the Rules. A person who identifies as LGBTQ who has experienced (or is about to experience) discrimination by a HUD-funded or FHA-insured housing provider or lender may report it to HUD by either <u>filing a complaint</u> or by <u>contacting a local FHEO</u> office.

Examples:

An underwriter for an FHA-insured lender is reviewing a loan application by two males; both incomes are being used as the basis for the applicants' credit worthiness. The underwriter assumes the applicants are a gay couple and, as a result, denies the application despite the fact that the applicants meet all requirements for the loan. This may violate HUD's Equal Access Rule, which prohibits FHA-insured lenders from taking actual or perceived sexual orientation into consideration in determining adequacy of an applicant's income.

Illegal Housing Discrimination

- 26 total complaints.
- In the past 4 years, a total of 8 complaints
- A vast majority of discrimination complaints involved disabilities (89% since 2016)
- Marketing and outreach should target fair housing rights for those with disabilities.

Status of complaints reported to HUD's Office of Ethics and Appeals Law Division

- 16 Successful Conciliation
- 7 No Cause Determination
- 3 Compliant withdrawn



Illegal Housing Discrimination

- 1. Revise City complaints process and procedures.
 - DCHD reorganized fair housing staff
 - Renewed executive emphasis on Fair Housing Task Force
 - Stronger departmental understanding of the complaints that are being reported
 - Improvements to City webpage are needed (ex. Fair Housing Dashboard)
 - Quarterly update to FHTF regarding status of fair housing complaints

2. Educate the public, agencies and housing providers.

- Expanded support of fair housing outreach sub recipient
- City is restructuring Fair Housing Education funding to directly contract with a marketing firm to increase visibility of Fair Housing.

Decrease residential patterns of protected class concentrations based on race, national origin and disability.

1. Increase the planning and implementation of programs that encourage the development of affordable housing in non-minority concentration areas

• Uptown and MCA prioritized for affordable housing development.

2. Continue focus of Fair Housing and Affirmative Marketing activities on identified minority areas

• The marketing strategy will target additional outreach efforts to areas of high racial or ethnic concentration.
