## What is a Code of Conduct?

- A Code of Conduct is a document that serves as an agreement of behavioral standards for all members of the organization.
- The document is helpful in directing and guiding all members of an organization on expected standards of conduct.
- All members are responsible for its adherence and will be held accountable.



## Who Currently has adopted a Code of Conduct?

- Large and small cities throughout the United States.
- Large enduring organizations such as United States Military.
- Large businesses, for example Google, Starbucks, The Coca-Cola Company and others.



## Why is it important?

- As appointed officials, your personal conduct and behavior is not only a reflection of who you are as individuals but also a reflection of the organization, the City of El Paso.
- Everyone must work together for the common good of the people of El Paso and not for any private or personal interest, and must assure fair and equal treatment of all persons, claims, and transactions.



## How does a Code of Conduct help our city?

- A Code of Conduct enhances the City's core values and sets the right organizational culture.
- It articulates the values the organization wishes to foster in leaders and employees and, in doing so, defines desired behavior.
- Is a central guide to support day-to-day operations and decision making.
- Serves as a public statement of the City of El Paso's commitment to high standards and proper conduct.



## **Benefits of a Code of Conduct**

- Demonstrates what we value and highlights our organizational culture.
- Enhances our reputation by treating each other and others with respect and dignity.
- Keeps us mindful of our behavioral standards.
- Fosters an environment of trust.



## Failure to adhere to the Code of Conduct may result in...

- Breeding internal and external hostility.
- Damaging the City's reputation in the community.
- Building distrust from residents, businesses, and potential business owners.

## Appointed Officials Conduct With One Another in Public Meetings

Practice civility, professionalism, and decorum during discussions and debate.

Refrain from making belligerent, personal, impertinent, slanderous, threatening, abusive, or disparaging comments.

It is the responsibility of the Chair to maintain order and keep the comments of appointed officials on track during public meetings.

Demonstrate effective problem-solving approaches to issues that may arise.





## Appointed Official Conduct With One Another in Private Encounters

Continue respectful communications in private. The same level of respect and consideration of differing points of view deemed appropriate for public discussions should be maintained in private conversations.

Be mindful that written notes, voicemail messages, and e-mails may be subject to the Texas Public Information Act.

Be mindful that private conversations can have a public presence.

## **Appointed Officials Conduct With City Staff**

All questions and/or requests for information should be directed to the designated staff member assigned to the Board/Committee.

Treat all employees/volunteers as professionals.

Do not disrupt employees/volunteers from their jobs.

Refrain from making personal attacks on an individual employee/ volunteer.

Do not get involved in administrative functions.

Requests for additional staff/volunteer support - even in high priority or emergency situations -- should be made to the City Manager who is responsible for allocating City resources and personnel.



## **Appointed Officials Conduct With Public In Public Meetings**

Be welcoming to speakers.

Be fair and equitable in allocating public hearing time to individuals speakers.

Be an active listener.

Ask for clarification, but avoid debate and argument with the public.

No personal attacks of any kind, under any circumstance.

Follow parliamentary procedure for the Board/Committee.



## **Appointed Officials Conduct With Public In Unofficial Settings**

Refrain from making promises on behalf of the City.

Appointed officials may be asked to explain a City Council action about an issue as they meet and talk with members of the community. It is appropriate to refer them to Mayor and Council or City staff for further information.

Refrain from making personal comments about elected or other appointed officials. It is acceptable to publicly disagree about an issue, but it is unacceptable to make derogatory comments about elected officials or other appointed officials, or their opinions and actions.



## **Appointed Officials Conduct With Other Public Agencies**

Be clear about representing the City or personal interests.

The Mayor represents the City in intragovernmental and intergovernmental relationships.

If an appointed official appears before another governmental agency or organization to give a statement on an issue, the appointed official must clearly state whether his or her statement reflects personal opinion or is the stance of the City.

If the appointed official is representing the City, the appointed official must support and advocate the official City position on an issue, not a personal viewpoint.



## Elected Officials Conduct With Other Elected/Appointed Officials

The City has established several Boards and Committees as a means of gathering more community input.

By serving on a Board or Committee, you are an appointed official and serve as an advisor to the Mayor and City Council. Appointed officials are a valuable resource to the City's leadership and should be treated with appreciation and respect.

Although not prohibited, appointed officials attendance at other City Board or Committee meetings is discouraged, based on the affect that their presence may have on the proceedings.

It is inappropriate for appointed officials to contact other appointed officials to lobby on behalf of an individual, business, or developer.



## Elected Officials Conduct With Other Elected/Appointed Officials

Appointed officials (Board/Committee members) report to the Mayor and City Council, not to individual Council members. Mayor and Council members should never feel they have the power or right to threaten appointed officials with removal if they disagree about an issue.

A Board or Committee appointment should not be used as a political "reward."

A primary role of Boards and Committees is to represent many points of view in the community and to provide the Mayor and City Council with advice based on a full spectrum of concerns and perspectives. Mayor and City Council members must be fair and respectful to all citizens serving on Boards and Committees.



# Conduct with the Media

Never say "No Comment."

Any appointed official that receives a request from media for comment or information should direct the reporter to the Board or Committee's assigned staff member or the City's Public Affairs Office

## Addressing Issues - Appointed Official to Appointed/Elected Official



If the behavior continues; member will need to inform the Chair.

Chair will inform assigned staff, who will follow process to inform the Mayor.

If it is the Chair's behavior in question, then member will inform assigned staff, who will follow process to inform the Mayor.

Mayor will work with the member to address the issue.



## **Behavior and Conduct**

- If the appointed official repeatedly fails to follow proper conduct, the City Council may remove the member from office.
- Any form of discipline imposed by City Council shall be determined by a majority vote of at least a quorum of the City Council.
