4. <u>Agenda Item #4.</u> Update and Discussion: Facility Maintenance Activities – Victor Rivera, Facilities Maintenance Superintendent

Victor Rivera, Facilities Maintenance Superintendent, reported on the following items:

- HVAC air conditioners will be switching over from heaters
- Armijo vandalism addressed (graffiti and swing sets)
- 5. <u>Agenda Item #5.</u> Update and Discussion: Athletic Field Lighting Update Paula Powell, Assistant Parks and Recreation Director

Paula Powell, Assistant Director, distributed a Quality of Life – Athletic Field Lighting printed PowerPoint presentation (Handout).

She informed the Board that the following parks have been completed: Sal Berroteran, Pico Norte and Blackie Chesher. The goal is to have lighting for sporting fields. There will be additional projects that will include lighting to park fields. Total limit on this project was \$500,000 as of 2016 there is a remaining balance of \$392,000. Next year it is anticipated that Ponder Park will have lighting, as there have been several requests for this park. Estimated amount for this project is \$300,000 for both diamond fields at Ponder Park.

For 2017 Galatzan flat fields will be on the list for lighting. There are no lit fields on the Westside of town. Remote controls will be used to light up parks and can be done through cell phones and Sue Young.

In 2018 the focus will be for Blackie Chesher and new infrastructure, a lot of electrical issues at the park. Amount estimated for park is \$600,000 since poles do not need to be replaced. The following older parks that need repairs and lighting are Irwin J. Lambka, Veterans flats/diamond fields, J.P. Shawver flats, Capistrano, Marty Robbins and Pavo Real.

6. <u>Agenda Item #6.</u> Update and Discussion: Youth Football Revisions – Paula Powell, Assistant Parks and Recreation Director

Paula Powell, Assistant Director, reviewed the youth football revisions which reduces the risk of concussions in children (Handout). Discussion ensued on the following Rules:

- Rule 1 Concussion training for all coaches and parents prior to fall season.
- Rule 2 Limit the number of games any player plays to one per week
- Rule 3 -- Require all city coaches of Middle Schools football players have less days of hitting in practice. City will not schedule games same day as Middle School games, this will protect players who play in both.
- Rule 4 Players can only play in one City league to lessen the number of games that a player plays, with will reduce players from excessive contact.
- Rule 5 Mighty Might Division will be modified to be 6 and 7 year olds only. Five year olds can join mini sports flag football; this will make this age group to be recreational and will not be Little Bowl or playoffs for this age group.
