CITY MANAGER Tommy Gonzalez assistance with intakes remains; the intake for December 2021 was 1,236. The outcome for December 2021 was 1,120 with the help of different adoption promotions that took place at The Winter Fest, local businesses and organizations. off-site events and the assistance from the Bissell Foundation. In the efforts to increase outcomes, adoptions will be the focus for 2022, so adoption opportunities will be incorporated in the Free Microchip Clinics. Ramon pointed out that the number of Return to Owner (RTOs) have gained momentum and Ani mal Services will continue to microchip as many pets possible as long as the national animal welfare partnerships continue their support and resources. There are 1,607 fosters out that includes the foster pets that are waiting for surgery to finalize the adoption. Ramon added that 3 traveling veterinarians are scheduled to arrive on February 7th and will stay through the 10th to help with surgeries. Another veterinarian will arrive at the end of February. Infectious and trauma were the two top reasons for euthanasia. The LRR was 80.65%, which was higher than November 2021 and the calendar year LRR was 84.27%. A transport of 80 to 90 dogs to Canada is scheduled for this weekend. Considering the outcome challenges that Animal Services continues to struggle with, these types of transports have made it possible to sustain a positive LRR. The total intakes for CAPS were 1,236, no appointment intakes were 362 and field intakes were 628. The Animal Shelter count LRR was 80.65% compared to 92.54% last year. The CAPS found reports created were 190 and community RTOs were 88. Ramon Herrera presented the PAW Cast.

Alexsandra Annello inquired whether there would be a decrease in non-essential employees per the discussion held by council on going back to phase 1 and would there be modifications with volunteers as well.

Ramon explained that all of Animal Services staff is essential. He is considering modifying the hours of operation by opening later to allow for cleaning and feeding of all animals. He added that an emergency response plan was placed in March of 2020 that does entails the reduction of intake, however with much of the staff out, the present shelter population needs to be taken care of.

Ramon also explained that Animal Services is getting the word out to the community on the Safe Outdoor Act through education. Animal Services started education outreach this week and also posted material on the website. He will have updates on the shelter's covid-19 situation as well as the outreach efforts.

Gina Gagen inquired about the horse that is currently at the shelter. Ramon explained that no one has reclaimed it yet. If not reclaimed, the horse needs to get the proper exams by the state veterinarian before adoption. Gina also inquired about where the veterinarians are from. Ramon explained that one of the vets was a former employee of Animal Services who is currently working in Kansas City.
