to overcome and gave an overview of the return to pre-pandemic operations. The intake for November was 1,377. To offset some of these intakes, the Bissell Foundation is sponsoring a transfer flight out to Canada in a climate control plane the second week of January 2022. In comparing the intakes, 2019 had 1,989 and 2020 had 551. Ramon credited the lower intake compared to 2019 to the additional services provided by Animal Services such as the Food Pantry and the microchipping clinics. The outcome for November was 1,159, this number included fosters and adoptions. The outcomes in comparison to 2021 were; 2,074 in 2019 and 655 in 2020. There are 1,500 fosters which includes foster to adopt pets that are waiting for spay/neuter surgeries. Animal Services is currently working with contract veterinarian to catch up on these surgeries to finalize adoptions. Dr. Medina is the new parttime veterinarian. Ramon explained that once he starts the vet recruitment, he will be able to place part-time and contact veterinarians to oversee the shelter's medical needs. Infectious and not thriving with treatment continue to be the main reasons for euthanasia, however there has been an increase in trauma (hit-by-car). The November LRR was 79.69% and the calendar year LRR was 84.60%. The shelter animals count was 79.69% compared to 82.08% in 2020. The community and pet support program served as a guide to assist the public for found pets during the pandemic and continues to assist the public today. The total intake with no appointment was 420 and 710 were taken in by Animal Protection Officers.

Ramon went over the strategic plan areas that staff emphasized after the survey results: Reduce the number of pets entering Animal Services, Provide a safe environment for employees and opportunities for professional development, and an Emergency Response Plan. He will present an update to ASAC at the January 2022 meeting.

Ramon Herrera presented the PAW Cast.

Regina Wagner requested to have agenda backup sent out prior to meeting. Gina Gagen thanked Ramon and Animal Services staff for a great job done. Ramon also thanked the Animal Services staff for giving their time for the livesaving mission and thanked the ASAC for their support.

#### C. El Paso County Animal Welfare Department November update.

Lauralei Combs mentioned that in November there was a 40% decrease in intake. She thanked officers for their commitment. She also mentioned that El Paso County and City of El Paso will collaborate in their first county clinic fund raiser Santa Paws held at Ascarate Park. The County clinic offers services to the county, city of El Paso, rescue groups and fosters. Lauralei explained that since August 2020, the county has utilized the City's Socorro clinic for no cost services which includes: spay/neuter, vaccinations and microchips. The clinic is held once or twice a month by Dr. Medina. The County impounds animals at Animal Services through an interlocal agreement and starting in January 2022, El Paso County Animal Welfare will service San Elizario. The county will also hire three new officers and get three new
