CITY MANAGER Tommy Gonzalez Ramon Herrera, Interim Director, thanked everyone for their support and added that it's been an honor to be part of the continual live saving mission. He spoke on how the strategic goals are an extremely important part of the life-saving efforts at Animal Services. The intake for January 2021 was 1,105. There was a 50% decrease of the population compared to previous years during the covid-19 closure; however, the shelter population has been increasing steadily. Historically, there has been more intakes than outcomes, but January was the first month to have more outcomes (1,186) than intakes. Foster parents continue to be an active and huge component in the livesaving goals. There are currently 443 pets out on foster. There were less than 100 animals euthanized and Ramon mentioned that now that Animal Services is saving more lives, they will take a closer look on how to help this population. The LRR for January was 93.02% with dogs at 92.76% and cats at 93.32%. The Calendar LRR was 93.02% and Fiscal year LRR was 89.69%. The Animal Shelter Count for January 2020 was 90.53% and 93.02% for January 2021.

Ramon Herrera presented the PAW Cast.

Ramon explained that Animal Services is still a participant with the HASS program. He will follow up with any updates.

B. El Paso County Animal Welfare Department January update
Lauralei Combs welcomed new ASAC member Karen Polanco and
congratulated Animal Services on the 93.02% LRR. She mentioned that in
January 2020 there were 261 animals taken to Animal Services compared to
76 in 2021. In the efforts of supporting Animal Services' strategic goal 1,
they are continuing to follow steps in trying to find pet owners. They have
nine kennels where the animals are kept for 3 days while trying to find
owners, place in either foster or rescue groups. The only animals taken to
Animal Services are ones with behavioral and medical issues. They also
offer a free clinic once a week to the community. In January, 41 pets were
spayed and/or neutered and over 200 pets were vaccinated. She also
mentioned that there are plans for a county shelter.

5. Main Agenda

A. Promote Education and Engagement of Animal Health and Welfare
A1. Presentation on an overview of the 2021 Texas Legislative Session on
Animal Bills

Gina Gagen gave an overview on the Texas Humane Legislative Network for the 2021 Texas Legislative Session which monitors laws that pertain to Animals in the community. One of the many victories was to keep the Licensed Breeders Program to stop cruelty and unethical puppy mill practices. The big Bill to support is the HB 873/SB 474, which clarifies how owners can properly restrain outside dogs and keep them safe. She went over several bills briefly: HB91-for community supervision for defendants convicted of criminal offenses; HB100- allows a municipal animal control authority to manage dangerous or aggressive dogs in the extraterritorial jurisdiction of the municipality; HB337-relates to the intake and disposition records of animal shelters and releasing agencies; HB580- to require a consumer warning upon sale of certain household plants that are hazardous when ingested by animals; HB762-relates to availability of removing certain individuals or animals from a motor vehicle. Gina explained that this bill refers to the removal of a distressed animal from a hot car. While legal protocols will continue to be followed, the bill will remove any civil liabiities for saving the animal(s).

Barbara Candelaria inquired about the status of legislation on groomers. Gina Gagen explained that there is nothing on groomer's legislation for this year. Wendy Vineyard will keep ASAC updated on which bills pass. Alexandra Annello suggested ASAC work on legislative City Council items for the 2022 Legislation Session.

- B. Research and Advise on Effective Ordinances ands Policies to Improve Overall, Health, Welfare and Safety for Animals
 - B1. Discussion and action on change in ASAC by-laws related to Article V.6.f. regarding responsibility for annual report.

Julie Rutledge explained that she placed this item for logistical awareness. She read from Article V.6.f. explaining that the by-laws are very specific when writing the annual report and her concern is the timeframe. If the same chair stays, from one year to the next, then it's not a problem. However, if a different chair is elected; the question is; who has to prepare the report., she added. She suggested coinciding the Annual report with the City's fiscal year instead of a calendar year, since the Title VII Ordinance does not specify on a timeline. Sandra DiFrancesco explained that due to the current situation, she

B2. Discussion and action on Election of Officers, Chair and Vice-Chair for the 2021 calendar year

Julie Rutledge opened the floor for nominations. Sandra DiFrancesco nominated Julie Rutledge for Chair and Gina Gagen for Vice-Chair; both accepted and Alexandra Annello seconded; all members voted in favor, and motion passed unanimously.

B3. Discussion and action on Community Involvement and Responsibilities related to stray animals and means of getting them back to their owner. No discussion, item was skipped.

B4. Discussion and action on draft of ASAC Annual Report to the Mayor and City Council.

Julie Rutledge presented the 2020 Annual Report outline to ASAC. The outline includes the statutory duties from Chapter 823, Texas Health & Safety Code and the El Paso City's Title 7 Ordinance. The outline also includes the following: El Paso County Animal Welfare Department changes, The HASS community initiatives and the statutory requirement status. She asked the committee for any input and also suggested creating a subcommittee within ASAC to keep track and assist with the shelters' compliance. Barbara Candelaria suggested including the collaboration between Animal Services and El Pasoans Fighting Hunger on the distribution of pet food, the community's involvement with fostering and how shelters became creative and innovative. Sandra DiFranceso suggested including the events held to support the community throughout the COVID closure. In spite of other city facilities being closed, Animal Services found creative ways to support the community, Representative Annello added. Ramon Herrera added that COVID brought more ways of connecting to the community and opened the way for different types of sheltering technology. Julie will present the annual report draft at the March meeting.
