




- 3. Discussion and action on Sub-committees' reports:
  - a. Free Roaming Cats Chairperson Regina Wagner provided a report on the status of several activities. Animal Services Officers will be given a presentation on the TNR program in order to help educate the public on how to reduce the number of free roaming cats in the community. Animal Services has approved the printing of the informational flyers. These flyers are being distributed by Animal Control Officers and staff to educate and empower citizen to be aware and help find solutions. Ms. Wagner also informed the committee that they are in desperate need of volunteers. Betty Hoover questioned what area of town are these volunteers needed. Ms. Wagner advised on all areas of town. Dr. Snyder has signed up to help with spay and neutering. Volunteers will begin trapping and the neighborhood association will pay Veterinarians directly for their services.

b. Public Education, Outreach, and Responsible Pet Ownership Chairperson Patricia Gonzalez informed the committee about a recent visit to Mesita Elementary School where Ms. Regina Wagner gave a presentation on the TNR and Spay & Neuter Programs. The response was very positive. Information on how to obtain cat traps was also provided. Ms. Gonzalez advised that she is in the process of reaching out to PTA's to

help educate children on the responsibilities of adoptions. Dr. Freund added that information could also be distributed during Book Fair events.

Motion made by Robert Melson and seconded by Linda Krasowski to have ESD/AS plan and implement an aggressive and comprehensive public education campaign addressing the key community animal welfare issues. ESD/AS will report with the plan within 90 days. Betty Hoover also stated that the plan should include issues such as responsible ownership, spay and neuter, vaccinations and registration. Robert Melson added that there is a misunderstanding of education. This plan is not for classroom or before a group. This education is to be given out on a radio or TV ad for public education of all citizens.

b. Action on Educational Media Campaign. Daniel Marin gave a power point presentation on billboard and signage designs. He went over several designs for buses, flyer and brochures. Mr. Marin advised that City Hall is displaying ads on cable channel 15. The Fountains of Farrah is also displaying ads and allowing for adoption events. Spay and Neuter flyers and brochures are available and the series will expand. Mr. Marin advised that he had spoken to movie theater representatives on running commercials and received several quotes.

6. Animal Services Monthly Operations Report. Daniel Marin read a request made from Ellen Smyth to the committee to have the Veterinarian Association report where the 10% of the total registration sales are being used for. Kurt Fenstermacher clarified to have the Veterinarian Association prepare and submit an Annual Report on how the funds are being spent. Daniel Marin went over the Adoptions Calendars. Rose Janice explained the outreach program Happy Trails which are a lesson plans for 3<sup>rd</sup> graders on Pet Responsibility. Ms. Janice informed on the progress of the VIP program. Mr. Rios gave a report on improvements and projects at the shelter. He mentioned that Texas Tech had donated a brand new walk-in freezer. The shelter is in

need of an industrial size washer and dryer set. The present washer and dryer have broken due to the high volume of washes. There are still problems with the draining system and are continuing in the efforts to find solutions.

7. Discussion and action on the process for setting up reviews of the process and procedures at Animal Services by ASAC members. It was decided that ASAC members will have access to information if requested. Staff will also be available if requested. A sub-committee of ASAC members will be responsible for these requests of information.
