Chair provided a short PowerPoint presentation to preface the larger discussion, briefly reviewing Animal Services' history, comparative statistics under the new leadership and Task Force, how today's changes came to be, sustainability and the focus going forward.

Julie Rutledge shared key points from a PowerPoint presentation that was given during the Austin Pets Alive Conference in February, regarding strategies to reach and sustain no-kill status.

Nicole Cote facilitated the strategic planning process, utilizing a SWOT analysis to begin the conversation (drafted notes attached here as part of these minutes).

Nicole Cote requested a motion to table the Strategic Planning session and reconvene on May 9th at 5:00pm. Charlie Moreno so moved; Amanda Herrera seconded; all members voted in favor, none opposed, and motion passed unanimously.
