CITY MANAGER Tommy Gonzalez B. El Paso Animal Services June update and statistics

With the high number of animals at the shelters during the peak season, Ramon Herrera mentioned that the theme for last month was to get as many animals out; Animal Services had a historical transport sponsored by the Bissell Pet Foundation. There are plans to update the Animal Services Strategic Plan sometime in November and it will include the input from staff and the ASAC. One of the items to be added is the services provided to the community outside the shelter. The intake for June was 1,222 compared to 2,806 in 2019. From the 1,222, 329 were kittens. A large number of cats from hoarding cases requiring immediate attention, added to the intake number. Currently the Socorro Rd facility is being used as emergency housing for several dogs. This created staffing challenges due to splitting staff between the two locations. There were 1,119 outcomes which included 268 adoptions in June. The shelter opened up again with its regular hours from 11AM to 6 PM and appointments are not required for adoptions. The public is strongly encouraged to stop by and search for their lost pets. Animal Services is striving to get everything back to normal by still following covid-19 guidelines now that 72% of the community is vaccinated with the first dose. The foster program currently has 684 animals in foster homes. There were 195 animals euthanized with 102 of them for infectious disease. Another mass vaccination clinic will take place sometime in August with The Bissell Pet Foundation providing the vaccines and microchips. The LRR for June was 80.67%, the number is a reflection of how distemper has affected the community dogs. The Fiscal Year LRR was 87,34% and the Shelter Animal Count was 80.67% compared to 87.26% in 2020.

Maddie's Shelter Medicine Program visited El Paso Animal Services from the University of Florida for an assessment. The assessment was for improvements and progress; a list of both is attached.

Ramon Herrera presented the PAW CAST.

Julie Rutledge congratulated Animal Services for their life-saving efforts with the transport and their National recognition.

Karen Polanco mentioned that she would spread the word to the Real Estate Board and to Property Managers regarding assistance with pets and also would contact the Director of the Convention and Visitors Bureau for assistance with arrangements to have veterinarians students visit El Paso.

### 5. Main Agenda

- A. Support the City of El Paso's initiative to reach and sustain a 90% or greater live-release rate by 2020.
  - A1. Disciussion and action on the need of veterinarians to be hired for EPAS programs in order to achieve/maintain no kill

Regina Wagner explained that in order to achieve no kill, the two most important programs are: Targeted Spay/Neuter Services to reduce the number of dogs and cats entering the shelter, and Trap-Neuter-Release for community cats. She explained that the resources are currently not meeting the demands. These programs cannot be sustained with the shortage of veterinarians at Animal Services and throughout the community. She stated that the current situation calls for ASAC to show support for the animals in this community; by sending a letter to Mayor and City Council expressing the importance of bringing Veterinarians to the city by offering incentives. Ramon added that Animal Services interviewed two candidates for the position, however they declined. He also mentioned that Eric Bohm from the EPVMA informed him that the private clinics are in need of 22 veterinarians and has been working diligently on recruitment. There are future plans to have veterinarian students take a tour of El Paso during the spring and winter months before graduation. Barbara Candelaria added that the shortage is nationwide. Ramon also explained that Animal Services has budgeted for 2 veterinarians and also designated funds for contract veterinarians, however the challenge is to sell El Paso. Regina expressed that contract veterinarians also help support lifesaving programs for other organizations; this means that we are not helping additional animals, but spreading the current resources very thin. Alexsandra Annello mentioned that she could place an item on the city agenda regarding this topic and Ramon could update the ASAC on the outcome. Ramon explained that Animal Services has taken steps in finding incentives and has drastically increased their offers to bring veterinarians to El Paso. He also mentioned that he and Eric Bohm, each have a list of contacts to start organizing a stay in El Paso for these students.

Regina Wagner motioned and Celeste Varela seconded for ASAC to write a letter to Mayor and City Council to strongly support the effort, including additional incentives to encourage veterinarians to come to El Paso and work with Animal Services; all voted in favor with one nay; the motion passed.
