Motion made by Mr. Baumgardt, seconded by Mr. Stapler AND UNANIMOUSLY CARRIED THAT THE OPEN SPACE ADVISORY BOARD RECOMMEND TO CITY STAFF AND COUNCIL THAT FUNDS THROUGH THIS TIRZ BE USED, THAT THE WHOLE PROJECT KEEP ARROYOS NATURAL AND THAT FUNDS FROM THE TIRZ BE USED TO PROPERLY DESIGN AND BUILD TRAILS TO THE ARROYOS TO REACH THE STATE PARK AND THAT SUFFICIENT ACCESS POINTS AND/OR TRAILHEADS ARE IN THE DESIGN AND PAID FOR THROUGH THE TIRZ.

Ms. Burt made the following friendly amendment: WOULD LIKE TO SEE NUMEROUS POINTS OF ACCESS, BECAUSE THIS ABUTS THE STATE PARK, THEY MAY ALL GO TO ONE TRAIL BUT THERE SHOULD BE NUMEROUS POINTS

Mr. Baumgardt accepted Ms. Burt's friendly amendment worded as follows: WE WANT NUMEROUS, SUFFICIENT ACCESS POINTS TO ALLOW (INAUDIBLE)

Mr. Stapler seconded the amendment.

Vice-Chairman Geyer was in favor of the motion but thought there might be other things that should be discussed and people in the audience who wish to speak on the item. He would like to get input prior to that June 6<sup>th</sup> meeting. Vice-Chairman wished to have one big document including what Mr. Baumgardt said.

Ms. Triggs stated the item will be brought back on June 6<sup>th</sup>. She believed it would be possible to have the one document with comments suggested from Mr. Baumgardt.

The vote was 5-1-1 (Vice-Chairman Geyer opposed, Ms. White abstained from the vote)
